WHEREAS, after the approval of the amendment of the provisions of the Code of General Ordinances the substitution of unit is allowed to the operators having an unexpired franchise or Motorized Tricycle Operators Permit (MTOP);

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable John Paul E. Erlano, it was;

RESOLVED, as it is hereby resolved to approve the application of the above-named applicants for the substitution of unit of Motorized Tricycle in the Municipality of Gubat, Sorsogon;
