A RESOLUTION ADOPTING MDC-EXECOM RESOLUTION NO. 4 S-2016, "A RESOLUTION AMENDING THE ANNUAL INVESTMENT PLAN FOR FISCAL YEAR 2016 OF THE MUNICIPALITY TO INCLUDE THE SALINTUBIG PROJECT "CONSTRUCTION OF WATER SYSTEM" WITH A GRANT OF ONE MILLION PESOS (P1,000,000.00) FROM THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG)".
