A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE V (DA-RFO V) WITH REGARDS TO THE IMPLEMENTATION OF UNIFIED NATIONAL INSEMINATION PORGRAM (UNAIP) IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, the Department of Agriculture (DA) through the National Livestock Program (NLP) is currently implementing the Genetic Improvement (GIP) of which the Unified National Insemination Program (UNAIP) is one of its major components;

WHEREAS, the implementation of this Unified National Insemination Program is a collaborative effort of the Bureau of Animal Industry, National Dairy Authority, Philippine Carabao Center and the Local Government Units through Municipal Agriculture Office;

WHEREAS, this local government unit signifies its intention to avail the program to strengthened support services to our local livestock breeders;

WHEREAS, one of the components of this UNAIP is to buy vital artificial insemination equipment and supplies for distribution to Philippine Carabao Center (PCC) trained AI Technicians for breeding services in the various barangays of this municipality;

WHEREAS, one of the requirements for the implementation of this program is to enter into mutual agreement with the Department of Agriculture, Regional Office V, to define its respective participation;

NOW THEREFORE, on motion of Hon. Cesar D. Esperida, Jr. and duly seconded by Hon. Danilo E. Enaje, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement with the Department of Agriculture, Regional Office (DA – RFO V) with regards to the implementation of Unified National Artificial Insemination Program (UNAIP) in the Municipality of Gubat, Sorsogon;
