(1) the Sangguniang Bayan has the power and duties to "approved ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and the punong barangay;
