RESOLUTION NO.195 S-2017

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR), SORSOGON PROVINCIAL OFFICE, REGARDING THE REPAIR OF MULTI-PURPOSE BUILDING/DISPLAY CENTER FOR GUBAT SPECIAL AGRARIAN REFORM COMMUNITY AND FARMERS ASSOCIATION (GSARCFA) OF BARANGAY BENTUCO, GUBAT, SORSOGON

WHEREAS, the Program Beneficiaries Development Division (PBDD) of the Department of Agrarian Reform (DAR) on March 3, 2017, launched the Strategic Alliance Building and Strengthening Partnership Development in Sorsogon through the signing of a general Memorandum of Agreement with the different LGUs in Sorsogon;

WHEREAS, one of the projects identified by DAR-Provincial Office (DARPO) for 2017 is the implementation of Sustainable Livelihood Project for Disaster Affected ARCs, one of which is located at Barangay Bentuco, Gubat, Sorsogon;

WHEREAS, one of the components of the Sustainable Livelihood Project is the repair of Multi-Purpose Building/Display Center for Gubat Special Agrarian Reform Community and Farmers Association (GSARCFA) of Barangay Bentuco, Gubat, Sorsogon, the Agrarian Reform Beneficiaries Organization (ARBO) in the area;

WHEREAS, the DARPO has allocated the amount of Php 200,000.00 for the repair of said multi-purpose building/display center;

WHEREAS, this local government unit is one of the signatories to the general Memorandum of Agreement to express its commitment to support the implementation of Sustainable Livelihood Project located at Bentuco, Gubat, Sorsogon;

NOW THEREFORE, on motion of Hon. Cesar D. Esperida, Jr. and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Agrarian Reform (DAR), Sorsogon Provincial Office, regarding repair of the multi-purpose building/display center for Gubat Special Agrarian Reform Community and Farmers Association (GSARCFA) of Barangay Bentuco, Gubat, Sorsogon;
