RESOLUTION NO. 197 S-2016

A RESOLUTION APPROVING THE APPLICATIONS FOR MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOPs) IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the sanggunian bayan shall have the authority to issue, revise, renew, suspend and cancel or declare the revocation and dropping of a franchise and prescribe appropriate terms and conditions therefore" (Chapter VIII, Article I, Section 24 of the Code of General Ordinances of the Municipality of Gubat);

WHEREAS, Chapter VIII, Article I, Section 10, of the same Code states that "No tricycle-for-hire or pedicab-for-hire either for passenger or for cargo or both, shall be operated in this municipality without a MTOP or POP from the Sanggunian Bayan and a corresponding permit from the Office of the Mayor under the Municipal Revenue Code";
