RESOLUTION NO. 197 S-2017

A RESOLUTION GRANTING FRANCHISE TO OPERATE A COCKPIT IN THE MUNICIPALITY OF GUBAT, SORSOGON TO MR. AVERY PUJOL, OWNER OF THE GALLERA DE GUBAT COCKPIT.

WHEREAS, Chapter IV, Art. C, Section 8 and 9, par. (a) of the Code of General Ordinances of the Municipality of Gubat mandates the owners and operators of cockpit to secure franchise for operation of cockpit in this municipality;

WHEREAS, aside from franchise issued by the Sangguniang Bayan, the Code also requires the operator and/or administrator of the cockpit to pay Mayor's Permit Fee for cockpit owners/operators, licensees and cockpit personnel;

WHEREAS, Mr. Avery Pujol, represented by Mr. Juan F. Espedillon, Jr., applies for the issuance of franchise and hereby assume the responsibility to pay all fees and charges and other incidental expense relative to its operation;

WHEREAS, the municipality reserves the right to revoke the franchise for any violation of existing laws, rules, orders, ordinances and other analogous decrees;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Kenneth D. Escandor and Hon. Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved, to granting franchise to operate a cockpit in the Municipality of Gubat, Sorsogon to Mr. Avery Pujol, owner and proprietor of the Gallera de Gubat cockpit;

RESOLVED FURTHER, that copy of this resolution be furnished Hon. Sharon Rose G. Escoto, Municipal Mayor; Mr. Reymundo F. Quiñones, Municipal Treasurer, LGU-Gubat, Sorsogon; Mr. Juan F.
