V, REGARDING THE USE OF ELECTRONIC MEDICAL RECORDS (EMR) SYSTEM FOR THE PRIMARY HEALTH CARE FACILITY OF THE LOCAL GOVERNMENT UNIT OF GUBAT, SORSOGON.

WHEREAS, this Local Government Unit of Gubat signifies its intention to enrol in the Electronic Medical Records (EMR) System of the Department of Health through the iClinic Sys, a reference model for electronic medical records and health information system for primary care facilities that satisfies Philippine Health Insurance Corporation requirements for benefit packages through capitation and DOH reporting necessities including national health data standards;

WHEREAS, this local government unit find it necessary to enter into mutual agreement with the Department of Health (DOH) for applicable guidelines, terms and conditions for the use of iClinicSys as an electronic medical record and health information system provider for health services, engaged to help manage the patient demographics, medical histories, diagnoses, treatments, medications, laboratory requests and results and generate the required data for the use of our health facility and also for submission to DOH and PhilHealth;

NOW THEREFORE, on motion of Hon. Valentin E. Pura and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Health (DOH) regarding the use of Electronic Medical Records (EMR) System for the Primary Health Care Facility of the Local Government Unit of Gubat, Sorsogon;
