A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REGIONAL OFFICE NO. V, WITH REGARDS TO THE IMPLEMENTATION OF SOCIAL PROTECTION PROGRAMS IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the Municipality through Memorandum of Agreement and in partnership with the Department of Social Welfare and Development (DSWD) agrees to engage in developing and implementation of social protection programs that will address the needs of the poor, empower citizens, and promote inclusive growth in the municipality;

WHEREAS, Social Protection Programs as a whole approach of the DSWD in ensuring convergence implementation of the department’s various strategies to address

the needs of the poor, are composed of some or all of the following PPAs (1) Access Roads (Farm-to-Market Road, Pathway); (2) Post Harvest Facilities and Livelihood Programs (Mechanical Drier, thresher, Starter Kits, Trainings); and (3) Schools;

WHEREAS, the Local Government Unit of Gubat recognizes its role in ensuring inclusive development, and commits to address the needs of the poor within its jurisdiction as part of its poverty reduction program;
