RESOLUTION NO. 32 S-2017

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOP) IN THE MUNICIPALITY OF GUBAT OF ALLAN L. DEDUQUE WITH CASE NUMBER 05-09-2017 AND FLORENTINA H. ENCELA WITH CASE NUMBER 05-09-796 FOR ONE YEAR STARTING THIS MONTH OF FEBRUARY 2017 UNTIL JANUARY 2018.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the applicants had applied before this office for the suspension of his MTOP for reason that his public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Nelson E. Quinones, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat of Allan L. Deduque with case number 05-09-2017 and Florentina H. Encela with case number 05-09-796 for a period of one year starting February 2017 until January 2018;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting January 2017;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicants and others concerned for their information and guidance.
