WHEREAS, the Local Government Unit of Gubat had previously entered into Memorandum of Agreement (MOA) with the Sorsogon Lady of Charity Home for the Aged concerning care of abandoned, neglected and indigent elderly residents of the municipality which term of coverage has expired last January 2017;
