RESOLUTION NO. 45 S-2017

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR’S PERMIT (MTO) IN THE MUNICIPALITY OF GUBAT OF REYNALDO L. FLORANDA WITH CASE NUMBER 05-09-2525, ROMEL E. LACANDULA WITH CASE NUMBER 05-09-2141, RENATO E. ENORME WITH CASE NUMBER 05-09-1764 AND BRENDA ENGAY WITH CASE NUMBER 05-09-2721 FOR ONE YEAR STARTING THIS MONTH OF MARCH 2017 UNTIL FEBRUARY 2018.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniangbayan;

WHEREAS, the applicants had applied before this office for the suspension of his MTO for reason that his public-utility-tricycle is under repair;

WHEREAS, the sangguniangbayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Danilo E. Enaje, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat of Reynaldo L. Floranda with case number 05-09-2525, Romel E. Lacandula with case number 05-09-2141, Renato E. Enorme with case number 05-09-1764 and Brenda Engay with case number 05-09-2721 for a period of one year starting March 2017 until February 2018;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting March 2017;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicants and others concerned for their information and guidance.
