RESOLUTION NO. 5 S-2017

A RESOLUTION EXTENDING THE TIME OF PAYMENT FOR LOCAL TAXES, FEES AND CHARGES OR PENALTIES, IN THE MUNICIPALITY OF GUBAT, SORSOGON, TO MARCH 31, 2017.

WHEREAS, as embodied in Section 167 of the Local Government Code of 1991, “All taxes, fees and charges shall be paid within the first twenty (20) days of January or each subsequent quarter as the case maybe;”

WHEREAS, Section 167 of R.A. 7160 likewise empowers the Sangguniang Bayan to “extend the time for payment of such taxes or charges without surcharges or penalties, but only for a period not exceeding six (6) months;”

WHEREAS, there is a necessity to extend payment in consideration of the negative impact to local business sector due to destruction of our Gubat Public Market by fire, sometimes in June 2014, which caused dislocations and tremendous decrease in their income;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to extend the time of payment for the local taxes, fees and charges for the year 2016 without surcharges or penalties, in the Municipality of Gubat, Sorsogon to March 31, 2017;
