RESOLUTION NO. 51 S-2017

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTO) IN THE MUNICIPALITY OF GUBAT OF ADOLFO ESTAREJA, JR. WITH CASE NUMBER 05-09-1844, JOSE E. ENAJE WITH CASE NUMBER 05-09-523 AND RAUL E. ESPINEDA WITH CASE NUMBER 05-09-1111 FOR ONE YEAR STARTING THIS MONTH OF APRIL 2017.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the applicant had applied before this office for the suspension of his MTO for reason that his public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat of Adolfo Estareja, Jr. with case number 05-09-1844, Jose E. Enaje with case number 05-09-523 and Raul E. Espineda with case number 05-09-1111 for a period of one year starting April, 2017;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting April 2017;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicants and others concerned for their information and guidance.
