RESOLUTION NO. 52 S-2017

A RESOLUTION SUSPENDING THE ISSUANCE OF NEW MOTORIZED TRICYCLE OPERATORS PERMIT (MTOP) IN THE MUNICIPALITY OF GUBAT, SORSOGON FOR A PERIOD OF FIVE (5) YEARS STARTING APRIL 28, 2017.

WHEREAS, Article Three, Section 447 (3) (vi) provides that, “Subject to the guidelines prescribed by the Department of transportation and Communications, regulate the operation of tricycles and franchises for the operation thereof within the territorial jurisdiction of the municipality”;

WHEREAS, the Local Chief Executive requested the suspension of issuance of new municipal tricycle operator’s permit for reason that the population per tricycle ratio in the Municipality exceeds to its adequate proportion rendering unhealthy competition and insufficient income on part of the drivers and operators, which at present there are a

total of 1,723 franchise holders in the municipality while the required number of tricycle units based on our population is only 600 units computed in 100 passengers daily per unit.

WHEREAS, Presidents of different tricycle drivers and operators associations, by unanimity, supports the call for the suspension due to the overcrowding of tricycle units operating within the small areas that could only lead to serious traffic congestion and disputes on the part of the unit's drivers and operators, which affects the maintenance of peace and order in the municipality;

WHEREAS, the operation of tricycle-for-hire, if not well regulated will eventually worsen the economic conditions of the transport sector as in reality the bigger the number, the lesser the income of workers relying their daily income from the operation of tricycles-for-hire adding the expenses for the maintenance needs and gasoline expenses of the vehicle and as a consequence, undue and unwarranted competition is unavoidable;

NOW, THEREFORE, on motion of Hon. Cesar D. Esperida, Jr. and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved to suspend the issuance of new Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat, Sorsogon, for a period of five (5) years starting April 28, 2017;

RESOLVED FURTHER, that the Secretary is directed to disseminate this notice for the information of all concern.
