A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ACCEPT A CONDITIONAL DONATION OF A LOT OWNED BY THE EPHICARIS T. GARCIA CONSISTING OF ONE THOUSAND (1000) SQUARE METERS LOCATED AT BARANGAY COGON, GUBAT, SORSOGON.

WHEREAS, Ephicaris T. Garcia is an owner in fee simple of a parcel of land situated at Barangay Cogon, Gubat, Sorsogon more particularly described as follows:

“A parcel of land (Lot A of the subdivision plan), being a portion of Lot 1922, Cad. 308-D Gubat Cadastre, situated in the barrio of Cogon, Municipality of Gubat, Province of Sorsogon. Bounded on the North by Lot 1916 of the Gubat Cadastre; on the South by Lot 1922 – D, of the subdivision plan; on the East by Lot 1922 – D of the subdivision plan and on the West by Lot 1917 of Gubat Cadastre. Containing an area of ONE THOUSAND (1000) SQUARE METER, more or less, with Tax Declaration No. 96-09014-0025 Assessed at P1000.00”

WHEREAS, for and on consideration of the love and affection which the DONOR has for the DONEE, the DONOR transfers and convey the above described property in favor of the Local Government Unit of Gubat to be used as Training Center of the Gubat Municipal Women's Group;
