A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR’S PERMIT (MTOP) IN THE MUNICIPALITY OF GUBAT OF RICARDO ESPEDIDO WITH CASE NUMBER 05-09-2340, GILBERT Y. INFANTE WITH CASE NUMBER 05-09-2316, JERRY E. DUKA WITH CASE NUMBER 05-09-2557, VICTORIA E. ESPENILE WITH CASE NUMBER 05-09-2065 AND ANNIE J. MASAGCA WITH CASE NUMBER 05-09-2046 FOR ONE YEAR STARTING THIS MONTH OF MAY 2017.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the applicants had applied before this office for the suspension of his MTOP for reason that his public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat of Ricardo Espedido with case number 05-09-2340, Gilbert Y. Infante with case number 05-09-2316, Jerry E. Duka with case number 05-09-2557, Victoria E. Espenile with case number 05-09-2065 and Annie J. Masagca with case number 05-09-2046 for a period of one year starting this month of May 2017;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting May 2017;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicants and others concerned for their information and guidance.
