V, WITH REGARDS TO THE IMPLEMENTATION OF THE EXPANSION OF RHU TB-DOTS CENTER OF THE MUNICIPALITY OF GUBAT THROUGH HEALTH FACILITIES ENHANCEMENT PROGRAM (HFEP) OF THE DEPARTMENT OF HEALTH (DOH)

WHEREAS, the Department of Health Central Office through the Health Facility Development Bureau provided the Regional Office V the approved list of health facilities under the 2016 HFEP;
