RESOLUTION NO. 75 S-2017

A RESOLUTION EARNESTLY REQUESTING FINANCIAL ASISTANCE TO HON. DEOGRACIAS B. RAMOS, JR., REPRESENTATIVE 2ND CONGRESSIONAL DISTRICT OF SORSOGON, FOR THE BACKFILL OF SITE/LOT INTENDED FOR THE CONSTRUCTION OF BULACAO NATIONAL HIGH SCHOOL SENIOR HIGH SCHOOL LABORATORY/TVL BUILDINGS.

WHEREAS, Article II, Section 3 of the 1987 Constitution provides that “the state recognizes the vital role of the youth in nation-building, and shall promote and protect their physical, moral and spiritual, intellectual and social-being;

WHEREAS, the Local Government Unit of Gubat through its functional Local School Board is envisioned to extend social services to its constituents by way of

supporting the undertakings of educational institutions within the jurisdiction of the municipality as part of the commitment of this LGU to deliver efficient and effective provision of basic services and facilities to its constituents;

WHEREAS, the General Parents-Teachers Association (GPTA) and faculty of Bulacao National High School through its Resolution No. 01 S-2017, requested to this local government unit through our local chief executive for possible assistance/funding intended for the backfill of the land perimeter area to be used as site for the construction of Bulacao National High School Senior High School Laboratory/TVL buildings;

WHEREAS, the Bulacao National High School is looking forward for the construction of the said senior high laboratory/TVL buildings considering that they are among those schools granted with six (6) 10x20 square meters laboratory buildings and one (1) 10x12 square meters single building by the Department of Education (DepEd);

WHEREAS, the construction of this buildings is of significant in preparation of the forthcoming implementation of the senior high school on the said school primarily to make senior high school available and accessible not only in barangay Bulacao but to the nearby barangays of Cabigaan, Sangat, Tabi, Naagtán and Bentuco;

WHEREAS, various similar request has been received by this local government unit from various elementary and secondary schools of this municipality of which this agency could no longer accommodate for reason of the huge amount needed, and considering further that the local budget was already appropriated for other priority/developmental program, projects and activities of the municipality, hence, financial assistance is earnestly requested;

NOW THEREFORE, on motion of Hon. Anthony C. Callos, and unanimously seconded by , it was;

RESOLVED, as it is hereby resolved, earnestly requesting financial assistance to Hon. Deogracias B. Ramos, Jr., Representative 2nd Congressional District of Sorsogon, for the backfill of the site/lot intended for the construction of Bulacao National High School Senior High School Laboratory Buildings/TVL Buildings;

RESOLVED FURTHER, that copy of the program of works and estimated costs for the project is attached to this resolution for your reference and evaluation;

RESOLVED FURTHERMORE, that copy of this resolution be furnished Hon. Deogracias B. Ramos, Jr., representative 2nd Congressional District of Sorsogon, for your favorable and appropriate action, and Hon. Sharon Rose G. Escoto, Municipal Mayor, LGU-Gubat, Sorsogon, Ms.Eleonora F. Polo, Principal I, Bulacao National High School and Mr. Roger Escorsa, GPTA President, for their information and guidance.
