RESOLUTION NO. 81 S-2017

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR), REGIONAL OFFICE NO. V, WITH REGARDS TO THE DISTRIBUTION OF FISH STALLS AND FREEZERS AT FISH LANDING CENTER TO THE QUALIFIED FISHERFOLKS OF THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, this local government unit has constructed fish landing center at Balud del Norte funded by the Bureau of Fisheries and Aquatic Resources (BFAR), and is now ready for occupancy to serve marginal fisher folks;

WHEREAS, as provided in the MOA, the BFAR will distribute fish stalls and freezer as part of the post-harvest and marketing components of Targeted Actions To Reduce Poverty and Generate Economic Transformation in the fishery sector (TARGET) program of the bureau;

WHEREAS, to facilitate the implementation of the distribution of fish stalls and freezers, this LGU will enter into MOA with the BFAR to define its respective responsibility and participation on the undertaking;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Kenneth D. Escandor and Hon. Nelson E. Quinones, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources (BFAR), Regional Office No. V, with regards to the distribution of fish stalls at fish landing facility to the qualified fisher folks of the Municipality of Gubat, Sorsogon;
