A RESOLUTION TO ELECT THE CHAIRMAN, VICE-CHAIRMAN AND MEMBERS OF THE SANGGUNIANG BAYAN COMMITTEE ON HOUSING AND LAND USE.

WHEREAS, by virtue of Municipal Ordinance No. 2017 – 002, the Sangguniang Bayan Committee on Housing and Land Use was created which is responsible for the study and review of proposals, projects and programs, pertaining to the use of land in the municipality, housing and subdivision proposals, and all matters pertaining to appropriation of lands within its jurisdiction;

WHEREAS, the same ordinance further provides that: *“the committee shall be in addition to the regular Sangguniang Bayan Standing Committees, the Composition of which shall be chosen by and between among the members in a manner as provided for under its Internal Rules”*;

WHEREAS, furthermore, Section 19 of Municipal Ordinance No. 2016 – 001 (Internal Rules of Procedures) states that: *The Sanggunian Bayan through an approved resolution in a session called for the purpose shall choose from among themselves the composition and membership of the respective committees, except those committees covered by statutory provisions”;*
