RESOLUTION NO. 84 S-2017

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOP) IN THE MUNICIPALITY OF GUBAT OF ARMANDO OSCILLADA WITH CASE NUMBR 05-09-2257 FOR A PERIOD OF ONE (1) YEAR STARTING THIS MONTH OF MAY 2017.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniangbayan;

WHEREAS, Armando Oscillada applied before this office for the suspension of their MTOP for reason that their public-utility-tricycle is under repair;

WHEREAS, the sangguniangbayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Nelson E. Quinones and Honorable Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat of Armando Oscillada for a period of one (1) year starting this month of May 2017;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting May 2017;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicant and others concerned for their information and guidance.
