WHEREAS, after the approval of the amendment of the provisions of the Code of General Ordinances the substitution of unit is allowed to the operators having an unexpired franchise or Motorized Tricycle Operators Permit (MTOP);

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Danilo E. ENaje, it was;

RESOLVED, as it is hereby resolved to approve the application of Nolito S. Escaros, Ricardo E. Funelas and Moises B. Amaro for the substitution of unit of Motorized Tricycle in the Municipality of Gubat, Sorsogon;
