A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENROL IN THE LANDBANK ELECTRONIC PAYMENT PORTAL AND TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE LANDBANK OF THE PHILIPPINES (LBP), SORSOGON BRANCH, AS A REQUIREMENT FOR THE IMPLEMENTATION OF THE PROJECT IN THE LOCAL GOVERNMENT UNIT OF GUBAT, SORSOGON

WHEREAS, the Local Government Unit of Gubat undertakes to enrol in the Landbank Electronic Payment Portal as part of the modernization of its facility to provide fast and efficient alternative payment collection services to the clientele;

WHEREAS, the Landbank Electronic Payment Portal (ePP), designed and operated by the LANDBANK, is a web-based payment system that allows partner-merchant’s clients to directly transact with the LANDBANK payment gateway or allows

partner-merchants to directly interface with the LANDBANK payment gateway, whichever is applicable;

WHEREAS, under Landbank ePP, LGU Gubat's client, through the web can access and pay their transactional fees and charges assessed online/manually by LGU-Gubat;

WHEREAS, preliminary to the implementation of this ePP, this local government unit is required to enrol in the said Landbank Electronic Payment Portal with the Landbank of the Philippines (LBP), Sorsogon Branch.

WHEREAS, the undertaking and implementation of the project are subject to the terms and conditions mutually agreed upon by the parties in a Memorandum of Agreement (MOA);

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. John Paul E. Erlano, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enrol in the Landbank Electronic Payment Portal and to enter into Memorandum of Agreement (MOA) with the Landbank of the Philippines (LBP), Sorsogon Branch, as a requirement for the implementation of the project in the Local Government Unit of Gubat, Sorsogon;
