## **EXECUTIVE ORDER NO. 2016-007**

## AN ORDER REORGANIZING AND STRENGTHENING THE MUNICIPAL PEACE AND ORDER COUNCIL (MPOC) OF THE MUNICIPALITY OF GUBAT

WHEREAS, Section 116 of RA 7160, otherwise known as the Local Government Code of 1991 mandates the establishment in every province, city and municipality of a local peace and order council pursuant to Executive Order No. 309, as amended, series of 1988;

WHEREAS, Executive Order No. 773 series of 2009 further reorganized the peace and order council of which the membership at the national, regional and local levels expanded;

**NOW THEREFORE I, SHARON ROSE G. ESCOTO,** Municipal Mayor of the Municipality of Gubat, province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

Section 2. Duties and Functions: The Council shall perform the following:

Formulate plans and recommend such measures which will improve or enhance

peace and order and public safety in their respective areas of responsibility;

Monitor the implementation of peace and order programs and projects of the municipality and the operation of Civilian Volunteers self-Defense Organizations and such other counter-insurgency programs and activities;

Make periodic assessment of the prevailing peace and order situation in their respective areas of responsibility and submit report thereon with recommendations to the Chairman of NPOC; and

Perform other functions assigned by law, the President, or the National Peace and Order Council.

Section 3. SECRETARIAT. There shall be established headed by DILG Officer assigned in the municipality to be assisted by the staff of the mayor and shall be responsible for Providing technical support, documentation of proceedings, preparation of reports and other assistance as may be required in the discharge of its functions.

Section 4. This order shall take effect immediately.
