**EXECUTIVE ORDER NO. 2016-009**

**AN ORDER ORGANIZING THE MUNICIPAL NUTRITION COUNCIL  
(MNC) OF THE MUNICIPALITY OF GUBAT**

**WHEREAS**, Section 16 and 17 (iv) of Republic Act 7160 otherwise known as the Local Government Code of 1991, mandates Local Government Unit to ensure general welfare and provision of basic services;

**WHEREAS**, the Local Government Code of 1991 provides for the meaningful participation of non-government and people's organization and the private sector in local governance;

**WHEREAS**, the code institutionalizes this participation through the creation serve as advisory and recommendatory bodies of every province, cities and municipalities as well as the barangay;

**WHEREAS**, there is a need to organize this council in this municipality and in compliance with the provisions set forth in the Local Government Code of 1991;

**NOW THEREFORE I, SHARON ROSE G. ESCOTO**, Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the organization of Municipal Nutrition Council.

**Section 1. Composition.** The Municipal Nutrition Council (MNC) is hereby organized to be constituted of the following:

**Section 2.** Duties and Functions. The MNC shall have the following duties and functions:

- (a) Formulate plan and other plans relative to nutrition programs;
- (b) Provide a forum for dialogue and deliberation of major issues and problems affecting Nutrition in the barangay;
- (c) Recommend measures which will improve or enhance health and nutrition in their respective areas of responsibility, including measures on malnutrition;
- (d) Recommend measures to address problems on health and nutrition;
- (e) Conduct Information Campaign, trainings and attend seminars related to health and nutrition;
- (f) Perform such other functions and duties related to Health and Nutrition and as prescribed by law.

**Section 3.** The MNC Secretariat. There shall be a MNC Secretariat designated by the LCE which shall be assisted in its functions and duties by the regular staff of the Council's Chairman.

**Section 4.** Effectivity. This order shall take effect immediately.

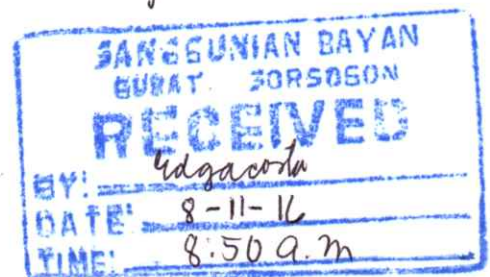
