EXECUTIVE ORDER NO. 2016-010

**AN ORDER ORGANIZING THE MUNICIPAL RABIES CONTROL  
COMMITTEE OF THE MUNICIPALITY OF GUBAT**

**WHEREAS**, it is the declared policy of the State to protect and promote the right to health of the people;

**WHEREAS**, Section 4 of RA 9482 mandates that there shall be a National Rabies Prevention and Control Program to be implemented by a multi-agency/multi-sectoral committee chaired by the Bureau of Animal Industry of the Department of Agriculture. The program shall be a multi-agency effort in controlling and eliminating Rabies in the country;

**WHEREAS**, Office of the Governor EO Order No. 004 s. 2016 directs all Municipal Mayors and City Mayor in the Province of Sorsogon to organize/reactivate their respective Anti-Rabies Committees and request their Sanggunian concerned to enact/amend ordinances implementing Section 7 of the Republic Act 9482 otherwise known as Anti-Rabies Act of 2007;

**WHEREAS**, there is a need to organize this committee in this municipality to prepare plans and effectively implement them in compliance with the provisions set forth in the RA 9482;

**NOW THEREFORE I, SHARON ROSE G. ESCOTO**, Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the organization of Municipal Rabies Control Committee.

**Section 1. Composition.** The Municipal Rabies Control Committee is hereby organized to be constituted of the following:

**Section 2. Roles and Functions of the Council.** The Rabies Control Committee shall exercise the following:

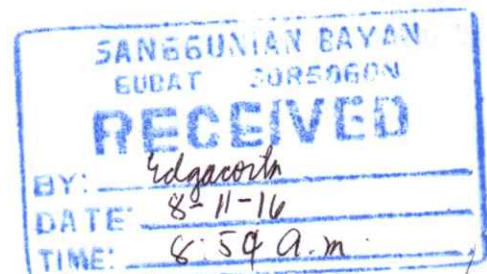
1. Oversee the over-all implementation of the rabies control program;
2. Provide a forum for an inter-agency coordination on rabies control and prevention program and formulate and implement immediate and long-term policies, plans and programs for the control of rabies;
3. Formulate proposals, measures, thrusts and strategies that would ensure the sustainability of the rabies control program;
4. Provide a medium for the involvement of all barangays in the control of rabies in the municipality, collate, consolidate and submit all necessary reports as required by higher authorities, and perform such other functions as may be necessary in the prevention and control of rabies;
5. And ensure compliance of all responsibilities of the LGU under RA 9482.

**Section 3. Effectivity.** This order shall take effect immediately.
