EXECUTIVE ORDER NO. 2016-011

**AN ORDER RECONSTITUTING THE MUNICIPAL DEVELOPMENT  
COUNCIL OF THE MUNICIPALITY OF GUBAT**

**WHEREAS**, Republic Act No. 7160 or the Local Government Code of 1991 mandates the formation of local special bodies in all municipalities;

**WHEREAS**, the NGO-members of the Municipal Development Council were elected during the CSO Assembly held at the St. Anthony of Padua Museum, Catholic Church Compound on October 23, 2015 in accordance with R.A. 7160 Sec. 108;

**WHEREAS**, the election of a new set of officials in the Municipality of Gubat last May 9, 2016, represents a new expression of the will of the people in the municipality, which needs to be reflected by a reconstitution of Municipal Development Council, a local special body mandated by the Local Government Code of 1991;

**NOW, THEREFORE, I, SHARON ROSE G. ESCOTO**, Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the authority vested in me by law do hereby order:

**SECTION 1. THE MUNICIPAL DEVELOPMENT COUNCIL (MDC)**

**A. Composition.** The MDC shall be composed of the following:

**B. Functions.** The Municipal Development Council shall exercise the following functions:

- (1) Formulate long-term, medium-term, and annual socioeconomic development plans and policies;
- (2) Formulate the medium-term and annual public investment programs;
- (3) Appraise and prioritize socioeconomic development programs and projects;
- (4) Formulate local investment incentives to promote the inflow and direction of private investment capital;
- (5) Coordinate, monitor, and evaluate the implementation of development programs and projects; and


(6) Perform such other functions as may be provided by law or competent authority.

**SECTION 2. REPEALING CLAUSE.** All prior issueances and orders inconsistent with this Executive Order are hereby repealed.

**SECTION 3. AUTOMATIC SUCCESSION OF MEMBERS.** In case of resignation, retirement, separation, transfer, re-assignment, removal of a member whose membership in any of the special bodies is mandated by law, the successor or replacement shall automatically take the position in the special body and shall serve only for the unexpired term. Provided that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

**SECTION 4. EFFECTIVITY.** This Executive Order shall take effect immediately and shall remain in force until rescinded, modified or supplemented.
