EXECUTIVE ORDER NO. 2016-017

**AN ORDER CREATING THE MUNICIPAL INTER-AGENCY TASK FORCE
FOR SURRENDERING DRUG USERS**

WHEREAS, the constitution mandates that the government shall promote the quality of life of the people;

WHEREAS, Section 16 or the General Welfare Clause of the Local Government Code of 1991 provides that Local Government Units shall, within their jurisdiction, promote health and safety, improve public morals, maintain peace and order, and preserve the comfort and convenience of their inhabitants, among other equally significant responsibilities;

WHEREAS, the number of surrendering drug users increases with the interventions done against illegal drugs;

WHEREAS, the establishment of the Municipal Inter-Agency Task Force in this municipality ensures proper assessment, intervention, rehabilitation, and continuous monitoring of surrendering drug users.

NOW, THEREFORE, I, SHARON ROSE G. ESCOTO, Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the authority vested in me by law do hereby order the following:

SECTION 1. Composition. The Municipal Inter-Agency Task Force for Surrendering Drug Users shall be composed of the following:




SECTION 2. The Municipal Inter-Agency Task Force for Surrendering Drug Users shall exercise the following functions:

1. Actual assessment and screening of surrendering drug users according to their level of risk.
2. Reproduction of assessment and screening tools, and training of support staff.
3. Conduct brief intervention to SDUs who are low risk.
4. Referral of high risk SDUs to Malinao Treatment and Rehabilitation Center.
5. Regular drug testing and continuous monitoring of SDUs
6. Perform other related duties and responsibilities.

SECTION 3. REPEALING CLAUSE. All prior issuances and orders inconsistent with this Executive Order are hereby repealed.

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain in force until rescinded, modified or supplemented.
