### **EXECUTIVE ORDER NO. 2016-022**

# AN ORDER ORGANIZING EXPANDED MUNICIPAL UGNAYAN NG BARANGAY AT SIMBAHAN (UBAS) AND ITS TECHNICAL WORKING GROUP (TWG) IN SUPPORT TO THE MASA MASID (MAMAMAYANG AYAW SA ANOMALYA, MAMAMAYANG AYAW SA ILEGAL NA DROGA) OF THIS MUNICIPALITY

WHEREAS, Section 116 of RA 7160, otherwise known as the Local Government Code of 1991 mandates the establishment in every province, city and municipality of a local peace and order council pursuant to Executive Order No. 309, as amended, series of 1988;

WHEREAS, Executive Order No. 773 series of 2009 further reorganized the peace and order council of which the membership at the national, regional and local levels expanded;

WHEREAS, Comprehensive Dangerous Drugs Act of 2002"(Republic Act 9165) - protects the state and its individuals from the possible harms brought about by the abuse of illegal drug substances;

WHEREAS, DILG Memorandum Circular No. 2015-63 or the "Revitalization of the Barangay Anti-Drug Abuse Councils (BADAC) and their Role in Drug Clearing Operations" which reinforces the mandate of the barangays to "adopt measures towards the prevention and eradication of drug abuse, etc." (Section 391, a20 of the LGC of 1991);

WHEREAS, DILG issued Memorandum Circular No. 2016-116 to address the long standing battle against criminality, corruption, and illegal drugs, the faith-based organizations and community volunteers will be engaged through the Ugnayan ng Barangay at Simbahan (UBAS). It will bank on the participation of the common people to spark the spirit of volunteerism in the community.

WHEREAS, as a strategy, it shall mobilize and converge the UBAS Barangay Action Teams. (BATs) with the member CSOs and NGOs of Barangay-Based Institutions, particularly the Barangay Anti-Drug Abuse Council (BADAC) and Barangay Peace and Order Council (BPOC) to advocate crime prevention, peace and order, security, and in enhancing transparency and accountability in the barangay. It will serve as an 'umbrella organization' of all barangay-based institutions concerned in advocating peace and order and public safety in the community;

WHEREAS, the program is designed to heighten community involvement by mobilizing the support of local stakeholders, volunteers, civic organizations, faith-based organizations and the private sectors in the fight against illegal drugs and criminality. Specifically, it aims to:

- a) Intensify the advocacy and education campaigns in the community level;
- b) Mobilize the community on gathering information by installing a reporting mechanism on illegal drug activities in the locality;
- c) Mobilize support and encourage sharing of available local resources to hasten the implementation of community-based rehabilitation program; and
- d) Create an enabling environment to encourage collaboration among the community partners to effectively implement the Community-Based Rehabilitation Program.

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of the municipality of GUBAT, province of Sorsogon, by the power vested in me by law, do hereby order and direct the following:

Section 1. Further Organization of the expanded UBAS and MASA MASID TWG. The TWG is hereby further reorganized to be constituted of the following:

The Expanded UBAS is responsible in convening, organizing, training and mobilizing the MASA MASID Team at the barangay level and steer the implementation of the program.

The MASA MASID Team (MMT) at the barangay level is the main implementing arm of the program.

Section 2. Duties and Functions: Expanded UBAS and/or UBAS-MASA MASID TWG

For DILG Municipal Field Offices, as chair of the Expanded UBAS TWG shall:

- Spearhead the organization and mobilization of the Expanded UBAS C/M TWG and MMT.
- Conduct orientation/training of the MMTs;
- Maintain a registry of the MMTs; and
- · Oversee the implementation of the MASA MASID Program within their jurisdiction and ensure its successful implementation.

# For MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) REPRESENTATIVE:

- Work closely with the DILG City/Municipal Field Office on the implementation of MASA MASID Program.
- Provide technical and administrative support; and
- Act as secretariat.

## THE LIGA NG MGA BARANGAY AS MEMBER OF THE EXPANDED UBAS TWG shall:

- Assist in the organization and orientation of the MASA MASID Team;
- Collaborate with the MMTs in the implementation of MASA MASID; Assist in coordinating
  with partner organizations for the provision of aftercare and livelihood program for the RDDs;
  and
- Conduct advocacy and information campaigns against illegal drugs within their jurisdiction

The members of the Faith-Based and Inter-Faith Organizations as member of the Expanded UBAS TWG shall:

- Assist in organizing and orienting the MMTs:
- Mobilize the support of faith-based organizations;
- Spearhead the advocacy and education campaigns in the community;
- Assist in the implementation of Community-Based Rehabilitation Program; and
- Assist in the implementation of community-based reintegration of the Recovering Drug Dependents back to the communities.

## The LOCAL PNP as member of the Expanded UBAS TWG shall:

- Assist in organization and in capacitating the MASA MASID Teams;
- · Provide technical assistance; and
- · Assess the reports submitted by the MMTs, and
- take necessary actions including, but not limited to, filing of cases and/or referral of drug users for counselling and/or rehabilitation, depending on the frequency of the use of illegal drugs;

Section 3. This order shall take effect immediately. DONE this 8<sup>th</sup> day of November 2016 at GUBAT, SORSOGON.
