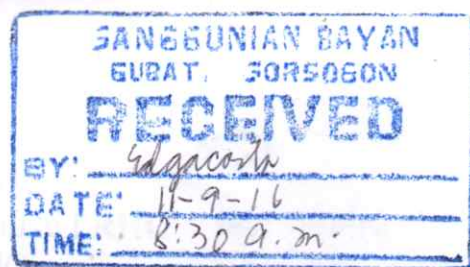

EXECUTIVE ORDER NO. 2016-023

REORGANIZATION OF THE MUNICIPAL BLOOD COUNCIL AND DEFINING ITS ROLES AND FUNCTIONS

WHEREAS, it is the responsibility of the state to ensure access to quality and affordable health products, devices, facilities and services, especially those commonly used by the poor. This includes provision of safe and adequate blood through an efficient blood services network;

WHEREAS, Republic Act 7719 otherwise known as the National Blood Services Act of 1994 ensures safe and efficient Blood Banking and transfusion practices in the Philippines;

WHEREAS, DOH Administrative Order No. 2008-0008 – Rules and Regulations Governing the Regulation of Blood Service Facilities established the National Council for Blood Services and the Philippine National Blood Services;

WHEREAS, these rules and regulations are promulgated to protect and promote the health of the people by ensuring available licensed blood service facilities with adequate staff, equipment and resources to perform all the required functions safely, efficiently and effectively;

NOW THEREFORE, I, SHARON ROSE G. ESCOTO, Local Chief Executive of the Municipality of Gubat, Sorsogon, by virtue of the powers vested in me by law, do hereby reorganize the Municipal Blood Council;

SECTION 2. ROLES AND FUNCTIONS. The Council shall perform the following:

- Prepare blood services operational plan and schedule of related activities
- Conduct training, pre and post-donation counselling for blood transfusion transmissible diseases, and information, education and communication (IEC) campaigns
- Keep a list of qualified voluntary blood donors in the government hospitals, rural health units, health centers and barangays
- Creation of multi-sectoral sub committees such as advocacy and promotion, programming, monitoring and evaluation of blood services program activities
- Promote and encourage voluntary blood donation and instill public consciousness of the principle that blood donation is a humanitarian act
- Inform the public of the need for voluntary blood donation to curb the hazards caused by commercial sale of blood
- Teach the benefits and rationale of voluntary blood donation
- Mobilize all sectors of the community to participate in mechanisms for voluntary and non-profit collection of blood
- Regulate and ensure the safety of all activities related to the collection of blood

SECTION 3. REPEALING CLAUSE. All prior issuances and orders inconsistent with this Executive Order are hereby repealed.

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately.
