EXECUTIVE ORDER NO. 2016-032

**AN ORDER CREATING THE LOCAL COMMITTEE ON ANTI-TRAFFICKING
AND ANTI-VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-AVAWC)**

WHEREAS, the protection of Filipino children remains to be national concern in view of the growing complexity of child protection issues in the country and the continued increase in the number of cases of child neglect, cruelty, exploitation and discrimination;

WHEREAS, Republic Act No. 7610, otherwise known as the "Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act", remains as the principal and comprehensive law for the protection of children against abuse and exploitation;

WHEREAS, Republic Act No. 9710 stated the rights and protection of women and their children;

WHEREAS, Executive Order No. 53 dated August 11, 2011 ordering the strengthening of the committee for the special protection of children, amending for this purpose Executive Order No. 275 (s. 1995);

WHEREAS, DILG, DSWD and DOJ Joint Memorandum Circular No. 2010-1 dated October 18, 2010 re: Creation of Local Committees on Anti-Trafficking and Anti-Violence against Women and Their Children (LCAT-AVAWC);

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of the municipality of GUBAT, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the creation of the Local Committees on Anti-Trafficking and Anti-Violence Against Women and Their Children (LCAT-AVAWC).

Section 2. DUTIES AND FUNCTIONS. The Committee on LCAT-AVAWC shall perform the duties and functions as prescribed:

1. Formulate Action Plan
2. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local ordinances and resolutions)
3. Create and establish systems on surveillance investigation and rescue to ensure effective and efficient coordination
4. Undertake information, education, and advocacy campaign against trafficking in persons and VAWC.
5. Monitor and oversee the strict implementation of RA 9208, RA 9262, and other related laws for the protection of women and children, and of the LCAT and AVAWC national plans of action.

In addition to the abovementioned functions, the committee shall implement the programs and activities in the national action plan.

Section 3. EFFECTIVITY. The Executive Order shall take effect immediately and shall remain enforce until rescinded, modified or supplemented.
