EXECUTIVE ORDER NO. 2018 - 011

ORGANIZING THE PLANNING TEAM CORE GROUP AND CREATION OF THE CLIMATE DISASTER RISK ASSESSMENT TECHNICAL WORKING GROUP OF THIS MUNICIPALITY

WHEREAS, Section 20 (c) of Republic Act 7160, otherwise known as Local Government Code of 1991, provides that "The local government units shall in conformity with existing law, continue to prepare their perspective Comprehensive Land Use Plan enacted through zoning ordinances which shall be primary and dominant bases for the future use of land resources";

WHEREAS, Executive Order No. 72 mandates all LGUs to update their Comprehensive Land Use Plan in conformity with the land use planning standards and guidelines prescribed by the Housing and Land Use Regulatory Board (HLURB) and to national policies;

WHEREAS, the HLURB Supplemental Guideline mandates that the LGU shall integrate the result of the Climate Disaster Risk Assessment in the CLUP formulation;

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

Section 1. Organizing the Planning Team Core Group which will mainly be responsible for coordinating the planning activities, as well as drafting and consolidating the contents of Climate Disaster Risk Assessment (CDRA) document and the submission of its final form before review and/or approving bodies like the Municipal Development Council, and its integration to the Comprehensive Land Use Plan (CLUP).
