EXECUTIVE ORDER NO. 2018-014

**CREATION OF THE MUNICIPAL PROJECT MONITORING
COMMITTEE (PMC) OF GUBAT, SORSOGON**

WHEREAS, there is a need to organize a committee to monitor and evaluate the implementation of various local government projects – (1) foreign and nationally-funded projects including development projects funded from the Internal Revenue Allotment (IRA) share of the LGUs or supported by funds released directly to the municipality and, (2) projects funded from locally generated resources;

WHEREAS, Executive Order No. 376 and as amended by Executive Order No. 93 provides for the creation/organization of Project Monitoring Committee (PMC);

WHEREAS, municipalities are enjoined to organize the local Project Monitoring Committee in their respective jurisdiction pursuant to DILG MC No. 2004-78;

NOW THEREFORE, I, SHARON ROSE G. ESCOTO, Municipal Mayor of the municipality of Gubat, province of Sorsogon, by virtue of the power vested in me by law, do hereby order the creation of Municipal Project Monitoring Committee of this municipality;

Section 2. POWERS AND FUNCTIONS

- Conduct regular inspection of projects, upon coordination with the implementing agency/ organization
- Provide a system for the integration, coordination, and linkage of all monitoring activities in the municipality
- Identify problems/issues, which impede project implementation for remedial actions
- Report unresolved issues and problems for resolution and final action through the Office of the Mayor
- Certify the completion of projects as per program of work or plan

Section 3. MEETINGS. The Municipal Project Monitoring Committee shall meet at least once every quarter or as often, as may be necessary to discuss all concerns, problems and issues affecting the implementation of various programs and projects, as well as the remedial actions recommended.

Section 5. REPEALING CLAUSE. All orders and issuances that are inconsistent with this order are hereby repealed or modified accordingly.

Section 6. EFFECTIVITY. This order shall take effect immediately.
