EXECUTIVE ORDER NO. 2018-16

CREATING THE LOCAL TOURISM DEVELOPMENT PLANNING COMMITTEE (LTDPC)

WHEREAS, local governments are mandated by the Local Government Code of 1991 otherwise known as R.A. 7160 to develop and promote tourism and the general welfare in their respective jurisdictions;

WHEREAS, DILG Memorandum Circular (MC) No. 95-162, encouraged Local Chief Executives (LCEs) to organize Tourism Councils in their jurisdictions, composed of government and private sector representatives to formulate programs and recommendations to develop local tourism facilities and attractions tapping local resources and funds;

NOW THEREFORE, I, SHARON ROSE G. ESCOTO, Mayor of the Municipality of Gubat, Sorsogon by virtue of the powers vested in me by law, do hereby order the creation of the Local Tourism Development Planning Committee.

I. Functions of the committee

- 1. Prepare a work plan for the preparation of the tourism plan
- 2. Formulate the tourism plan
- 3. Consult with residents and other stakeholders of tourism areas

II. Composition of the Committee. The committee shall be headed by the Municipal Mayor who shall serve as the chairperson.

III. Roles of the Committee

The Chairperson shall have the principal responsibility for directing and overseeing the development of the tourism plan, according to schedule. The chairperson is responsible for chairing major tourism planning sessions, and shall designate a representative in sessions that he/she will not be present.

The Committee shall actively participate in all activities identified in the work plan. The team shall develop realistic goals, appropriate strategies and identify programs, projects and activities that best contribute to the attainment of the tourism goals and objectives of the locality.

IV. Composition and Functions of the Technical Working Group (TWG) of the Local Tourism Development Planning Committee. The TWG of the LTDPC is composed of six (6) representatives from six (6) sectors. It shall be headed by the Mayor, however, he/she may delegate and appoint others who have the tourism technical capacity and competency to serve as the convener and secretariat of the said TWG.

The TWG shall serve as the technical assessors and evaluators of the potential tourism sites/attractions within the municipality. It shall also represent the LTDPC in the Local Tourism Development Planning and Workshop to be conducted by DOT ROV in order to formulate the initial draft of the LTDP to be presented to the LTDPC for evaluation and consensus.

The Municipal Tourism and Cultural Affairs Office shall be the secretariat of the committee to prepare and submit report to the Mayor for information and guidance.
