EXECUTIVE ORDER NO. 2018- 20 - A

ORGANIZING THE LOCAL YOUTH DEVELOPMENT COUNCIL OF GUBAT 2018- 2019

WHEREAS, Article 2 Section 13 of the 1987 Constitution states that, "the States recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social well being". It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs;

WHEREAS, Chapter 3 of RA 10742 or the Sangguniang Kabataan (SK) Reform Act states that, "there shall be a Local Youth Development Council (LYDC), which shall assist the planning and execution of projects and programs of the SK, and the Pederasyons in all levels;

WHEREAS, it is a declared policy of the LGU to promote and protect the physical, moral, spiritual, intellectual, cultural and social well-being of the youth and to inculcate in them values of patriotism and nationalism and to encourage their involvement in the public and civic affairs of the municipality;

WHEREAS, it is the duty of the municipality to reach out to the youth in the municipality and to encourage them to actively participate and be involved in its programs; and

WHEREAS, the Local Government of Gubat would like to ensure that the youth are given priority and that programs and policies will be truly beneficial to them.

NOW THEREFORE, I, **SHARON ROSE G. ESCOTO**, Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

SECTION 1. NAME AND NATURE OF COUNCIL. The council shall be known as the "Local Youth Development Council of Gubat". It shall be under the Office of the Mayor and the auspices of the Local Youth Development Office (LYDO).

SECTION 2. GENERAL OBJECTIVES:

- 1. To develop and harness the full potential of the youth as responsible partners in nation-building;
- 2. To encourage intensive and active participation in all government and non-government programs, projects, and activities for the youth;
- 3. To harmonize all government and non-government initiatives for the development of the youth sector;
- To supplement the local government's appropriation for youth promotions and development; and
- 5. To broaden and strengthen the services provided by the municipality and its counterparts in the barangays to the youth sector.

Specific Objectives:

- 1. To broaden and strengthen the services provided by the national government agencies, LGU, NGOs, and private agencies to young people;
- 2. To provide information mechanism on youth opportunities on the areas of health, education, economic empowerment, social inclusion and equity, peace building and security, governance, active citizenship, environment, global mobility, sports and recreation, capability-building and networking, and other relevant issues of the youth;
- 3. To involve the youth of Gubat and make them partners in development; and
- 4. To provide monitoring and coordinating mechanisms for youth programs. projects, and activities.

SECTION 3. COMPOSITION OF THE COUNCIL. The council shall be composed of at least ten (10) but not more than twenty-one (21) members including the two (2) core members from SK the president and the vice-president of the concerned Pederasyon, and eight (8) to nineteen (19) other representatives from registered youth organizations or youth serving organizations chosen by consensus based on the process as prescribed in the SK Reform Act.

SECTION 4. FUNCTIONS.

- a. Ensure wide and multi-sectoral youth participation in governance and provide support for the development and coordination of youth projects:
- b. Formulate the Local Youth Development Plan (LYDP);
- c. Assist in the planning and execution of projects and programs of SK and of the Pederasyon at all levels;
- d. Coordinate and harmonize activities of all agencies and organizations in the locality who are engaged in youth development;
- e. Implement programs aimed at developing the full potential of the youth;
- f. Empower the youth through information, education, and communication strategies to heightened awareness on various issues affecting the youth;
- g. Recommend youth programs and project proposal to appropriate government agencies;
- h. Monitor and evaluate the implementation of the LYDP; and
- Perform such other functions as may be required by the Municipal mayor and the law.

SECTION 5. SECRETARIAT. The Local Youth Development Office (LYDO) shall serve as the secretariat of the Local Youth Development Council (LYDC).

SECTION 6. LOCAL YOUTH DEVELOPMENT PLAN. The council shall formulate and adopt a Local Youth Development Plan, which shall be the basis for the implementation of local youth development programs and services in coordination with the concerned agencies. This shall include but not limited to youth development programs and youth development services.

SECTION 7. MEETING OF THE COUNCIL. The council shall meet quarterly or as maybe deemed necessary. The Chairperson or his duly designated convener shall preside in all council meetings.

SECTION 8. BUDGET. Resources shall be allocated from the Youth and Sports budget of the municipality.

SECTION 9. REPEAL CLAUSE. All other policies or laws creating organizations, councils or board in the municipality that exist having similar program with the Local Youth Development Council are hereby repealed.

SECTION 10. SEPARABILITY CLAUSE. If any provision or part thereof is held invalid or unconstitutional, the remainder of the law or the provision not otherwise affected shall remain valid and subsisting.

SECTION 11. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately until its expiration on 30 June 2019.
