**EXECUTIVE ORDER NO. 2018-021**  
**REORGANIZING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC)**

**WHEREAS**, the constitution mandates that the government shall promote the quality of life of the people;

**WHEREAS**, Section 16 or the General Welfare Clause of the Local Government Code of 1991 provides that Local Government Units shall, within their jurisdiction, promote health and safety, improve public morals, maintain peace and order, and preserve the comfort and convenience of their inhabitants, among other equally significant responsibilities;

**WHEREAS**, increasing use of illegal drugs post a threat to the health, welfare, peace and order of the community;

**WHEREAS**, the establishment of the Municipal Anti-Drug Abuse Council (MADAC) in this municipality is a venue to ensure the strength of our campaign against all forms of illegal drugs.

**NOW, THEREFORE, I, SHARON ROSE G. ESCOTO**, Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the authority vested in me by law do hereby order the following:

**SECTION 1.** Reorganization of the Municipal Anti-Drug Abuse Council. The MADAC shall be composed of the following:

**SECTION 2.** The Municipal Anti-Drug Abuse Council shall exercise the following functions:

1. Plan, strategize, implement and evaluate programs/projects on drug abuse prevention in the municipality;

2. Refer users and pushers to the police and other institutions for corresponding sanctions, rehabilitation and/or counseling;
3. Coordinate and collaborate with other institutions implementing programs/projects on drug abuse at the barangay level;
4. Continuously gather and update data on drug abuse and its effect on the pushers;
5. Perform other related duties and responsibilities.

**SECTION 3. REPEALING CLAUSE.** All prior issuances and orders inconsistent with this Executive Order are hereby repealed.

**SECTION 4. EFFECTIVITY.** This Executive Order shall take effect immediately and shall remain in force until rescinded, modified or supplemented.
