EXECUTIVE ORDER NO. 2018-023
ORGANIZATION OF THE BARANGAY HEALTH BOARD

WHEREAS, one of the primary responsibilities of local government units is to provide a health system that is equitable and responsive to the health needs of the constituents;

NOW, THEREFORE, I, SHARON ROSE G. ESCOTO, Municipal Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the powers vested in me by the Local Government Code of 1991, and other existing laws, do hereby order and direct the organization of the Barangay Health Board (BHB) in every barangay of Gubat, Sorsogon.

SECTION 1. COMPOSITION. The BHB shall be composed of the following:

Chairman	:	BARANGAY CAPTAIN
Vice-Chairman	:	MIDWIFE
Members	:	BARANGAY KAGAWAD FOR HEALTH BARANGAY SECRETARY BARANGAY HEALTH WORKER BARANGAY NUTRITION SCHOLAR BARANGAY TREASURER PARENT LEADER SK CHAIRMAN DEPED REPRESENTATIVE KPC CHAIRMAN

Membership of the BHB may be expanded to other identified stakeholders in the barangay.

SECTION 2. FUNCTIONS. The BHB shall perform the following functions:

1. Prepare Annual Health Plans, in accordance with standards, criteria and priority programs set by the Municipal Health Office;
2. Allocate budget for the implementation of the health programs and maintenance of the health facilities and services within the locality;
3. Provide legislative support to health programs, ensure availability and accessibility of basic barangay health services, medicines, and adequacy and compensation of community volunteers;
4. Initiate community-driven health programs and ensure community participation in the implementation of the programs;
5. Serve as the advisory committee to the Municipal Local Health Board on health matters such as area-based program planning for health, community health and organization, maternal and infant death reviews, among others.

SECTION 3. MEETINGS AND QUORUM

1. The BHB shall meet at least once a month or as often as may be necessary;
2. A majority of all its members shall constitute a quorum, but the chairman or vice chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

SECTION 4. COMPENSATION AND REMUNERATION

The chairman, the vice chairman and members of the Barangay Health Board shall perform their duties as such without compensation and remuneration. Members thereof who are not government officials and employees shall be entitled to necessary travelling expenses and allowances chargeable against the funds of the BHB, subject to existing accounting and auditing rules and regulations.

SECTION 5. REPEALING CLAUSE. All prior issuances inconsistent herewith shall be deemed superseded by this order.

SECTION 6. EFFECTIVITY. This order shall take effect immediately.
