EXECUTIVE ORDER NO. 2018-027

CREATING THE MUNICIPAL DENGUE FEVER PREVENTION AND CONTROL TASK FORCE IN THE MUNICIPALITY OF GUBAT

WHEREAS, this administration recognizes the significance of preventing and controlling Dengue Fever being one of the killer diseases based on the past records;

WHEREAS; the outbreak of this viral disease which is transmitted by a bite of an infected aedes mosquito occurs every three years and common at the start of the rainy season particularly on the month of July;

WHEREAS; the prevention and control of the said viral disease needs the involvement of the different sectors of the community which include the government institutions, non-government organizations, civic and religious organizations, schools (private and public), local officials and media;

WHEREAS; we firmly believe that to achieve this goal, the Local Government Unit thru the Rural Health Unit should lead in the mobilization of the different sectors aforesaid;

NOW, I SHARON ROSE G. ESCOTO, of the Municipality of Gubat, Sorsogon by virtue of the power vested in me by law do order the following:

Section 1. Creation. The Municipality Dengue Fever Prevention and Control Task Force in the Municipality of Gubat is hereby created.

Section 2. Composition. The Task Force shall be composed of the following:

Section 3. Functions. The functions of the Task Force shall be as follows:

1. Formulate plans and programs for the prevention and control of DHF/DF for the approval of the Municipal Mayor.
2. Coordinate/assist the community and other sectors in sustaining the Dengue program.
3. Mobilize the community and other sectors in the implementation of the plans and programs.
4. Evaluate and monitor the implementation of the projects and activities of the Dengue program.

Section 4. Effectivity. This order shall take effect immediately.
