### EXECUTIVE ORDER NO. 2019- 07

#### **AN ORDER DIRECTING THE INTERIM OPERATION OF THE PAMANA TERMINAL AND TEMPORARY TRAFFIC SCHEME TO DECONGEST TRAFFIC AT THE MUNICIPALITY'S CENTRAL BUSINESS AREA**

**WHEREAS**, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that the local government unit shall exercise the powers in the maintenance of peace and order, and the preservation of comfort and convenience of its inhabitants;

**WHEREAS**, DILG and DOTr Joint Memorandum Circular No. 001 Series of 2017 mandates the LGUs to prepare and implement the Local Public Transport Route Plan (LTPRP);

**WHEREAS**, Article C of Municipal Ordinance No. 2007-004 defines the traffic regulation within the market site;

**WHEREAS**, there is an ongoing construction of covered line canal on major roads in the municipality and construction of the C-Section of the new market building;

**WHEREAS**, there is a necessity to regulate the flow of traffic as a necessary tool for the maintenance of peace and order within the municipality, and in promotion of public safety and order;

**NOW THEREFORE I, SHARON ROSE G. ESCOTO**, Municipal Mayor of Gubat, Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

#### **SECTION 1. INTERIM OPERATION OF THE PUJS AND BUSES AT PAMANA TERMINAL.**

1. All Public Utility Jeeps and Buses will load and unload their passengers at the PAMANA Terminal starting Monday, March 25, 2019.
2. Parking of PUVs at the PAMANA Terminal is not allowed.

#### **SECTION 2. LOADING FOR PUBLIC UTILITY JEEPNEYS (PUJS) AND BUSES.**

1. All PUVs shall load passengers at PAMANA Terminal.
2. All northbound PUVs plying the route from PAMANA Terminal will take the length of Bonifacio Street and exit in either Aguinaldo Street, or Padrique Street;
3. All southbound PUVs plying the route from PAMANA Terminal will take the length of Bonifacio Street and exit point will be at Manook Street, Barangay Panganiban;


**SECTION 3. UNLOADING FOR PUBLIC UTILITY JEEPNEYS (PUJS) AND BUSES.** All PUJs and buses arriving at Gubat shall unload passengers at PAMANA Terminal.

1. From northbound routes, PUVs to enter the length of Quezon Street and turn right at Calderon Street to PAMANA Terminal.
2. From southbound routes, PUVs to enter the length of Manook Street and turn left at Calderon Street to PAMANA Terminal.
3. All PUVs are prohibited to unload passengers along Manook Street.

**SECTION 4. REPEALING CLAUSE.** All prior issuances and orders inconsistent with this Executive Order are hereby repealed.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately and shall remain in force until rescinded, modified or supplemented.
