EXECUTIVE ORDER NO. 2019- 015

CONSTITUTING THE MUNICIPAL ASSESSMENT TEAM FOR THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAY (SGLGB)


WHEREAS, the Philippine Constitution declares that the maintenance of peace and order, the protection of life and liberty, and property and the promotion of the general welfare are important in a democracy;

WHEREAS, the Local Government Code of 1991 provides for a continuing mechanism to enhance local autonomy through legislative acts and administrative and organizational reforms toward a continuing improvement of the performance of local government units and the quality of life, such that the latter shall exercise its powers essential to the promotion of the general welfare and provision of basic services and facilities;

WHEREAS, pursuant thereof and the significant role of the barangay in the overall development and transformation of the community and of the nation, the Department ought to implement the Seal of Good Local Governance for Barangay to challenge the barangays to raise their performance and practices of good governance with utmost regard to its fundamentals such as accountability, transparency, participation and responsiveness/effectiveness;

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of Gubat, Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the constitution of the Municipal Assessment Team for the Seal of Good Local Governance for Barangay (SGLGB):

SECTION 1. COMPOSITION. The SGLGB shall be composed of the following:

- RAMILO FAJARDO - Liga ng mga Barangay Acting President *for memorandum 9/3/19*
- KRISTIN ANTIVOLA - Representative from the Mayor's Office
- SALVACION DELMONTE - GWGMF, CSO Representative *[Signature]*

SECTION 2. DATA GATHERING, VALIDATION AND CERTIFICATION AND ON-LINE DATA ENTRY.

1. On Data Gathering, each barangay shall make sure that the data are accessible to the Municipal Assessment Team;




2. On Data Validation and Certification, barangays shall be expected to cooperate with the Municipal Team in the conduct of validation and certification through documentary review and onsite inspection to ensure reliability and quality data;
3. Online Data Entry at the SGLGB online database shall be the responsibility of the DILG-MLGOO.

SECTION 3. MOBILIZATION OF THE TEAM. To ensure functionality of the SGLGB Municipal Team, and to facilitate their onsite validation and inspection, the LGU shall assign a service vehicle for the purpose.

SECTION 4. EFFECTIVITY. This order shall take effect immediately.
