EXECUTIVE ORDER NO. 2019- 07-A

AN ORDER DIRECTING THE NEW TEMPORARY TRAFFIC SCHEME TO DECONGEST TRAFFIC AT THE MUNICIPALITY'S CENTRAL BUSINESS AREA

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that the local government unit shall exercise the powers in the maintenance of peace and order, and the preservation of comfort and convenience of its inhabitants;

WHEREAS, DILG and DOTr Joint Memorandum Circular No. 001 Series of 2017 mandates the LGUs to prepare and implement the Local Public Transport Route Plan (LTPRP);

WHEREAS, Article C of Municipal Ordinance No. 2007 - 004 defines the traffic regulation within the market site;

WHEREAS, the municipality implemented a trial run of the temporary traffic scheme through Executive Order No. 2019-07;

WHEREAS, upon assessment of the first trial run, the Local Public Transport Route Team deemed the temporary traffic scheme ineffective;

WHEREAS, there is a need to create another traffic scheme to decongest the traffic at the municipality's central business area;

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of Gubat, Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

SECTION 1. LOADING FOR PUBLIC UTILITY JEEPNEYS (PUJs).

1. All PUJs shall load passengers at the PAMANA Terminal.
2. All northbound PUJs plying the route from PAMANA Terminal will take Calderon Street, turn left and exit through the length of Manook Street.
3. All southbound PUVs plying the route from PAMANA Terminal will take Calderon Street, turn right and exit through the length of Manook Street.

SECTION 2. UNLOADING FOR PUBLIC UTILITY JEEPNEYS.

1. All PUJs and buses arriving at Gubat shall unload passengers at PAMANA Terminal.
2. From northbound routes, PUJs shall turn right at Padrique Street, take the length of Bonifacio Street, turn left at Calderon Street to PAMANA Terminal.

- 3. From southbound routes, PUJs shall turn left to Bonifacio Street and turn right at Calderon Street to PAMANA Terminal.
- 4. All PUJs are prohibited to unload passengers along Manook Street.

SECTION 4. REPEALING CLAUSE. All prior issuances and orders inconsistent with this Executive Order are hereby repealed.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect on March 28, 2019 at 6 o' clock in the morning to March 30, 2019.

The second trial run shall be assessed after three days. If found effective shall continue to be in force. If found ineffective, the same shall be subject to further management of the Local Public Transport Route Team.

Upon evaluation, the LPTRT shall select from the two implemented schemes and shall be forwarded to the Sangguniang Bayan as basis for amendment to the existing ordinance.
