The Local Government Unit of Gubat, through its TF-LGSF MDRRMF Aid for Tall Volcano Eruption, 20% Local Development Fund, Special Trust Fund LDRRMO and General Fund-Continuing intends to apply the sum of Three Million Five Hundred Thirty Thousand-Three Hundred Sixty Three Pesos (₱3,530,363.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Improvement of Malidlid Bridge with identification no. PR 12338. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Gubat now invites bids for the above Procurement Project. Completion of the Works is required 150 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from Local Government Unit of Gubat and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm, Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on July 30, 2021 to August 18, 2021

from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (₱5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees which will be presented in person, by facsimile, or through electronic means.

- 6. The Local Government Unit of Gubat will hold a Pre-Bid Conference on August 6, 2021, 9:00 am at Municipal Conference Room, Bldg. I, Municipal Compound, Manook Street, Gubat, Sorsogon which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on August 18, 2021, 9:00 am at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Local Government Unit of Gubat reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
