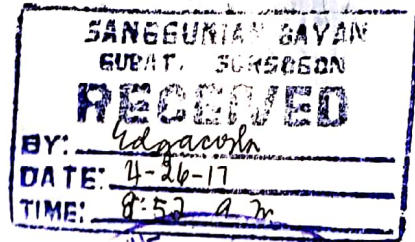

EXECUTIVE ORDER NO. 2017-010



**CREATING THE LOCAL INTER-AGENCY COMMITTEE ON PERMANENT HOUSING
AND OTHER SHELTER ASSISTANCE, DEFINING ITS COMPOSITION, FUNCTIONS,
AND OTHER ATTENDANT REGULATIONS**

WHEREAS, Section 28 of Republic Act 7279 and its Implementing Rules and Regulations, mandates the LGU, in coordination with National Housing Authority (NHA) and other agencies, the relocation and resettlement of persons living in danger areas such as riverbanks, waterways, among others and provide relocation and resettlement sites and basic services and facilities, access to employment and livelihood opportunities sufficient to meet the basic needs of the affected families;

WHEREAS, natural disasters, insurgency, relocation projects, demolitions, and other similar events may left households homeless and displaced;

WHEREAS, the Writ of Demolition issued by Hon. Bernardino R. Jimenez, Executive Judge, Branch 54, Regional Trial Court Carpio, Gubat, Sorsogon in Civil Case Nos. 2011-08/2018 – 2030 dated 8 May 2013 has awarded the contested lot measuring 95,109 square metres to the plaintiff, Gubat National High School (GNHS);

WHEREAS, qualified displaced families would need permanent homes located in safe, well-planned, and sustainable communities;

WHEREAS, there is a need to integrate and maximize the resources of government and other participating entities in providing permanent housing for the affected households;

WHEREAS, there must be an organized and well-coordinated committee composed of the LGU, national government agencies, and other concerned NGOs, POs, private sector, and other stakeholders to act as the decision-making, coordinating and consultative body, to include supervision and monitoring of the sub-committees that shall implement and/or cause the carrying out of the various activities, plans, programs and projects.

NOW THEREFORE, I, SHARON ROSE G. ESCOTO, Municipal Mayor of Gubat, Sorsogon, by virtue of the power vested in me by law, do hereby order the following:

Section 2. FUNCTIONS

1. Formulate policies and guidelines to ensure standardization of shelter assistance implementation including social preparation, selection, arbitration, award;
2. Enable all project stakeholders to participate in planning and implementation of a comprehensive Permanent Housing Program;
3. Integrate and maximize available resources from all participating entities adopting a common terms of reference for site planning and development to include the menu of housing options and assistance;
4. Define and agree on the structure for coordination, authority levels, and delivery of services;
5. Ensure adherence to the provisions of the Urban Development and Housing Act of 1992 or RA 7279, on the relocation and resettlement of families; and
6. Monitor the implementation of plans, programs, and projects as well as the operations of the sub-committee under it and submit regular reports to LG/HUDCC/NHA.

Section 3. EFFECTIVITY. This order shall take effect immediately.
