EXECUTIVE ORDER NO. 2017-012

DESIGNATION OF LOCAL YOUTH DEVELOPMENT OFFICER

WHEREAS, Republic Act 10748, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015 and its Implementing Rules and Regulations, provides for the creation of a Youth Development Office in every province, city and municipality;

WHEREAS, in view thereof, all Provincial Governors and Mayors are encouraged to designate a Local Youth Development Officer;

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the designation of MR. PATRICK OMAR B. ERESTAIN as the LOCAL YOUTH DEVELOPMENT OFFICER.

Section 1. The Local Youth Development Officer will be responsible to lead the Local Youth Development

Office with the following functions: 1. In accordance with Section 24 (d) of these rules, register and verify youth and youth-serving organizations (Subject to the revitalized LGU Youth Organizations' Registration Program (YORP)

2. Provide technical assistance to the LYDC of the concerned LGU in the formulation of the LYDP;

3. Facilitate the election of the LYDC representatives;

4. Serve as secretariat to the LYDC;

- 5. Conduct the mandatory and continuing training of SK officials and LYDC members, in accordance with the programs jointly designed and implemented by the National Youth Commission (NYC) and DILG. The local youth development officer and/or his or her staff shall apply for accreditation from NYC in order for them to conduct the mandatory and continuing training programs of SK officials and LYDC members. In the absence of the Youth Development Office in the province, city or municipality the designated eliciting personnel by the LCE shall apply for accreditation with the NYV in order for said official to conduct the mandatory and continuing training programs of SK officials and LYDC members;
- 6. Provide technical, logistical and other support in the conduct of the mandatory and continuing training programs, and to such other programs of NYC and DILG;

7. Coordinate with the Commission, with regards to the youth programs within their jurisdiction; and

8. Perform such other functions as may be prescribed by law, ordinance, or as the LCE, the DILG or the NYC may require.

Section 2. Effectivity. This order shall take effect immediately.
