EXECUTIVE ORDER NO. 2017-013

RE-ORGANIZATION OF THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN(LCPC) AND INTER-AGENCY MONITORING TASK FORCE, AND CREATION OF ECCD COORDINATING COMMITTEE; MONITORING, REPORTING, RESPONSE SYSTEM TEAM ON GRAVE CHILD RIGHTS VIOLATIONS; AND JUVENILE JUSTICE WELFARE COMMITTEE UNDER THE LCPC OF THIS MUNICIPALITY

WHEREAS, the protection of Filipino children remains to be national concern in view of the growing complexity of child protection issues in the country and the continued increase in the number of cases of child neglect, cruelty, exploitation and discrimination;

WHEREAS, Republic Act No. 7610, otherwise known as the "Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act", remains as the principal and comprehensive law for the protection of children against abuse and exploitation;

WHEREAS, Executive Order No. 53 dated August 11, 2011 ordering the strengthening of the committee for the special protection of children, amending for this purpose Executive Order No. 275 (s. 1995);

WHEREAS, DILG MC No. 2008-126 dated August 21, 2008 encouraged the LGUs to organize/reorganize their respective LCPC pursuant to Republic Act Nos. 4881 and 8980 and Presidential Decree No. 603;

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the reorganization of the Local Council for the Protection of Children (LCPC).

Section 1. THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC)

TIES AND FUNCTIONS:

1. Conduct regular quarterly meetings and special meetings when necessary;

2. Update and or compile database on children;

3. Prepares Council AWFP for inclusion in the local development plan and annual budget;

4. Conduct capability building programs for all stakeholders on children;

5. Conduct advocacy on the promotion of the rights and welfare of children;

- 6. Formulate a) Local Development Plan for Children (LDPC); b) Local Investment Plan for Children (LIPC); e) Local Code for Children (LCC); and d) Local State of Children Report (LSCR);
- 7. Assist Children in Need of Special (CNSP) and referral of cases filed against child abusers to concerned agencies/institutions;
- 8. Monitor of the enforcement of national and local laws for the survival, development, protection and participation of children;
- 9. Monitor and Assess the PPAs on children being undertaken by the LGUs in their respective localities which shall include among others the following:
 - a. Establishment or improvement of the standard day care centers, recruitment of trained/capacitated day care workers, etc;
 - b. Elimination of all forms of child abuse (i.e. worst forms of child labor, child trafficking, child prostitution and pornography);

c. HIV/AIDS prevention

- d. Implementation of intervention and diversion programs for CICL as provided for in Section 18 of RA 9344:
- e. Health and Nutrition Programs (i.e. immunization, salt iodization, feeding programs, micronutrient supplementation, etc.);

f. Maternal and post-natal care;

- g. Construction/maintenance of community infrastructures like children's playground and library, youth centers, etc
- h. Strengthening the family through parental care and guidance, family week celebration, parent education:

i. Provision of potable water supply;

j. Services and programs that respond to the special needs, interests and concerns of children and offer appropriate counselling and guidance to these children and their families; and

k. Training/capability building of service providers for children.

MONITORING AND EVALUATION. INTER-AGENCY MONITORING TASK FORCE (IMTF) shall be created in every LGU to monitor and evaluate the functionality of the LCPC

FUNCTIONS:

Coordinate the delivery of services and support from the NECCDCC and the national line 1. agencies involved in ECCD programs;

upport and complement the resources available to municipality and barangays in the 2. expansion and improvement of ECCD programs;

- 3. Actively support the development and implementation of the Human Resource Development Program for ECCD service providers and supervisors at the municipal and barangay levels;
- 4. Maintain an ECCD management information system including a registry/directory of ECCD programs and service providers;
- 5. Facilitate the accreditation process of ECCD programs and services in coordination with the national government agency concerned:
- 6. Prepare the Municipal ECCD program and plan of action and its corresponding annual investment plan by integrating inputs of barangays;
- 7. Adapt a municipal system for the early identification, prevention, referral and intervention of development disorders and disabilities in early childhood consistent with the national
- 8. Assist in the organization of barangay ECCD coordinating committees;
- 9. Monitor all ECCD program and projects including workplace based program at the municipal and barangay levels and submit periodic reports to the RSCWC;
- 10. Initiate and support legislations of the Sangguniang Bayan relative to ECCD system;
- 11. Promote and encourage private sector initiatives for the establishment of ECCD programs;
- 12. And such other functions as the NECCDCC may direct.

Section 4. MONITORING, REPORTING, RESPONSE SYSTEM TEAM ON GRAVE CHILD RIGHTS VIOLATIONS shall be created under the LCPC

FUNCTIONS:

- 1. Gather, validate and monitor reports of incidents of grave child rights violations (GCRVs) from national government agencies (NGAs), non-government organizations (NGOs), Local Government Units (LGUs), peoples' organizations (POs) and faith-based organizations (FBOs);
- 2. Ensure provisions of appropriate and timely inter-agency response to grave child rights violations, through coordination and efficient referral system;
- 3. Provide reports/updates on the incidence of GCRVs to the CWC Board through the RMG for policy issuance and program development; and
- 4. Provide relevant inputs to the CWC data-base on GCRVs.
- 5. Prepare periodic MMRS reports for submission to appropriate agencies.

Section 5. JUVENILE JUSTICE WELFARE COMMITTEE shall be created to oversee the implementation of R.A. No. 8371 and all rules issued in relation thereto.

FUNCTIONS:

1. Coordinate the implementation of the juvenile intervention programs and activities by national government agencies and other activities which may have an important bearing on the success of the entire national juvenile intervention programs. All programs relating to juvenile justice and welfare shall be adopted in consultation with the JJWC.

- 2. Call the attention of the department agencies concerned to perform their respective duties and responsibilities under the Act and these Rules and assist them if necessary to ensure the effective implementation of the Act.
- 3. Mobilize resources and call upon government agencies as well as private organizations to provide resource assistance to support the implementation of the Act.

Section 6. REPEATING CLAUSE. All issuances, memoranda and special orders issued inconsistent herewith are hereby superseded, repealed and amended accordingly.

Section 7. SEPARABILITY CLAUSE. If any provision of this resolution found to be unconstitutional or inconsistent with any national or local laws, ordinances or resolutions, all the other provisions thereof shall remain in full force and applicable.

Section 8. EFFECTIVITY. This order shall take effect immediately.
