EXECUTIVE ORDER NO. 2017-017

**AN ORDER SUPPORTING E.O. 26 OF PRESIDENT RODRIGO R. DUTERTE
PROVIDING FOR THE ESTABLISHMENT OF SMOKE-FREE ENVIRONMENTS
IN PUBLIC AND ENCLOSED PLACES**

WHEREAS, Republic Act No. 9211, or the Tobacco Regulation Act of 2003, prohibits smoking in certain public places, and prohibits the purchase and sale of cigarettes and other tobacco products to and by minors and in certain places frequented by minors and provides penalties for any violation of the prohibitions;

WHEREAS, Executive Order No. 26 of President Rodrigo R. Duterte provides for the establishment of smoke-free environments in public and enclosed places. All municipalities are enjoined to form a Local Smoke-Free Task Force to help carry out the provisions of this order;

WHEREAS, Section 15 of the 1987 Philippine Constitution declares, "The State shall protect and promote the right to health of the people and instill health consciousness among them";

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby support E.O. 26 of President Rodrigo R. Duterte and order the Creation of Gubat Smoke-Free Task Force.

Section 2. DUTIES AND FUNCTIONS OF SMOKE-FREE TASK FORCE

1. Information, Education, and Communication campaign about this order on Smoke-Free Environment.
2. Members of the PNP should apprehend violators and institute criminal proceedings for violations of this order.
3. All Punong Barangays are the persons-in-charge of their respective barangays and should lead the creation of Barangay Smoke-Free Task Force through a barangay resolution.
4. PSDS and Principals/Director/School Heads are the persons-in-charge of their respective schools.
5. GUSOJODA and TODA presidents are persons-in-charge of public transport.
6. The business sector representative and the Market Supervisor are the persons-in-charge of the business establishments and the market.

(Persons-in-charge duties and obligations are stated in Section 5 of EO 26 of President Duterte.)

7. All persons-in-charge should coordinate with the PNP, MSWDO, and the Municipal Health Office to develop, promote, and implement the Local Smoking Cessation Program.
8. Plan Designated Smoking Areas (DSAs) to strictly comply with the standards stated in Section 4 of EO 26.
9. All other duties and functions necessary to help carry out the provisions of this order.


Section 3. PENALTIES. Violations of this order shall be punishable in accordance with the applicable penalties provided under Section 32 of RA No. 9211 and other applicable laws.

Section 4. FUNDING. The amount necessary to implement the provisions of this order shall be identified by the Municipal Budget Office. The appropriations necessary for continued implementation of this order in succeeding years shall be prepared in accordance with regular government budget procedures and shall be included in the budget.

Section 5. SEPARABILITY CLAUSE. If any section or part of this order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

Section 6. EFFECTIVITY. This order shall take effect immediately.
