EXECUTIVE ORDER NO. 19 s. 2017

AN ORDER CREATING MASA MASID STEERING COMMITTEE (MMSC) AND RE-ORGANIZING EXPANDED UGNAYAN NG BARANGAY AT SIMBAHAN-TECHNICAL WORKING GROUP (E UBAS-TWG) IN SUPPORT TO THE MASA MASID (MAMAMAYANG AYAW SA ANOMALYA, MAMAMAYANG AYAW SA ILEGAL NA DROGA) PROGRAM THIS MUNICIPALITY.

WHEREAS, Section 116 of RA 7160, otherwise known as the Local Government Code of 1991 mandates the establishment in every province, city and municipality of a local peace and order council pursuant to Executive Order No. 309, as amended, series of 1988;

WHEREAS, Executive Order No. 773 series of 2009 further reorganized the peace and order council of which the membership at the national, regional and local levels expanded;

WHEREAS, Comprehensive Dangerous Drugs Act of 2002" (Republic Act 9165) - protects the state and its individuals from the possible harms brought about by the abuse of illegal drug substances;

WHEREAS, DILG Memorandum Circular No. 2015-63 or the "Revitalization of the Barangay Anti-Drug Abuse Councils (BADAC) and their Role in Drug Clearing Operations" which reinforces the mandate of the barangays to "adopt measures towards the prevention and eradication of drug abuse, etc." (Section 391, a20 of the LGC of 1991);

WHEREAS, DILG issued Memorandum Circular No. 2016-116 encourages the involvement of the community in the eradication illegal drugs, criminality and corruption. It also adopts a multi-sectoral and mass-based approach to ensure an effective and efficient implementation of the program.

WHEREAS, as a strategy, it shall mobilize and converge the UBAS Barangay Action Teams (BATs) with the member CSOs and NGOs of Barangay-Based Institutions, particularly the Barangay Anti-Drug Abuse Council (BADAC) and Barangay Peace and Order Council (BPOC) to advocate crime prevention, peace and order, security, and in enhancing transparency and accountability in the barangay. It will serve as an 'umbrella organization' of all barangay-based institutions concerned in advocating peace and order and public safety in the community;

WHEREAS, The program is to encourage and sustain community involvement to demand accountability of the government to address the problems on illegal drugs, corruption and criminality and in effect, promote good governance;

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of the municipality of GUBAT, province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

Section 1. Creation of MASA MASID Steering Committee. To ensure the operationalization and functionality of the E-UBAS TWG and MASA MASID Teams, a MASA MASID Steering Committee is hereby created to be constituted of the following:

The Expanded UBAS shall be the prime movers in the organization and operationalization of MASA MASID PROGRAM in the community. Specifically, responsible in convening, organizing, training and mobilizing the MASA MASID Team at the barangay level and steer the implementation of the program.

Section 2. Duties and Functions of MMSC and E- UBAS TWG:

MMSC:

- 1. Ensure the coming together of all stakeholders
- 2. Oversee the implementation of the MM program
- 3. Encourage a health relationship within and among all partners
- 4. Provide resources

E-UBAS TWG:

- 1. Ensure a close coordination with the Steering Committee and the MASA MASID Teams
- 2. Convene and mobilize the MASA MASID Teams
- 3. Assist in the planning and implementation of MASA MASID activities
- 4. Conduct regular monitoring of the MASA MASID teams and their activities
- 5. Consolidate reports submitted by the MASA MASID teams
- 6. Implement systematic monitoring and reporting mechanism
- 7. Maintain the local hotline lodged at the Local Police Station
- 8. Provide the appropriate technical and administrative assistance to the program

LG Municipal Field Offices, as chair of the Expanded UBAS TWG shall:

- Spearhead the organization and mobilization of the Expanded UBAS C/M TWG and MMT.
- Conduct orientation/training of the MMTs;
- Maintain a registry of the MMTs; and
- Oversee the implementation of the MASA MASID Program within their jurisdiction and ensure its successful implementation.

Section 3. FUNDING. Section 51 of RA 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, the LGUs shall appropriate a substantial portion of their respective annual budgets to assist in or enhance the enhancement of the Act giving priority to preventive or educational programs and the rehabilitation of drug dependents.

Section 4. PENAL PROVISIONS

- 1. Failure of the concerned officials to allocate a substantial portion in the annual budgets shall be ground for disapproval of the proposed annual budget pursuant to Section 60 of RA 7160.
- Failure of the local officials to take appropriate measures to enforce the pertinent provisions in RA 9165 shall be considered prima facie evidence for administrative charges per sections 9 of RA 3109 and 11 of RA 6713.

Section 5. EFFECTIVITY. This order shall take effect immediately.
