EXECUTIVE ORDER NO. 20-S 2017

**TEMPORARY TRAFFIC ORDER WITHIN THE MARKET SITE  
AND KEY ROADS IN GUBAT, SORSOGON AND DEFINING THE TRAFFIC  
ENFORCEMENT THEREOF**

**WHEREAS**, Section 16 of the RA 7160 or The Local Government Code of 1991 states that the local government unit shall exercise the powers in the maintenance of peace and order, and the preservation of comfort and convenience of its inhabitants;

**WHEREAS**, DILG and DOTr Joint Memorandum Circular No. 001 Series of 2017 mandates the LGUs to prepare and implement the Local Public Transport Route Plan (LTPRP);

**WHEREAS**, Article C of Municipal Ordinance No. 2007-004 defines the traffic regulation within the market site;

**WHEREAS**, there is an ongoing construction of covered line canal on major roads in the municipality and the construction of the C-Section of the new market building;

**WHEREAS**, there is a necessity to regulate the flow of traffic as a necessary tool for the maintenance of peace and order within the municipality, and in the promotion of public safety and order.

Now therefore, I, **SHARON ROSE GLIPO-ESCOTO**, Municipal Mayor of Gubat, Sorsogon, by virtue of the powers vested in me by the Constitution and Laws do hereby order the following:

**Section 1. Functions of the Traffic Enforcers**

1. Enforce the provisions of Municipal Ordinance No. 2007-004 and assist the regular members of Gubat PNP in the enforcement of all the national laws and related local ordinance on traffic regulation applicable to the national highway and streets within the Municipality of Gubat, Sorsogon;
2. Keep records of the names, addresses, driver's license numbers, and registration and plate numbers of vehicles, of all violators of aforementioned laws and ordinances;
3. Apprehend any person violating any provision of the same laws and ordinances, and issue Citation Ticket thereof after informing the apprehended violator of the violation committed. Any penalty or fine shall be paid to the Municipal Treasurer's Office (MTO);
4. Perform such other functions as maybe directed by the Municipal Mayor or his direct superior on matter pertaining to traffic enforcement and management and the implementation of related ordinances and national laws and regulations; and
5. Act as enforcer of other national laws or local ordinances, when violated in their presence.

## **Section 2. Loading and Unloading for Public Utility Vehicles (PUVs) and Buses**

1. All PUVs arriving at Gubat can unload passengers at the following:

From North Bound Routes: Two (2) designated areas along West Side of Manook St. Private parking is prohibited at all times in the aforementioned unloading areas.

*Unloading Area 1:* In-front of Cebuana Lhuellier/ Big Kier Enterprises  
*Unloading Area 2:* In-front of DLTBCo bus station

From South Bound Routes: Two (2) designated areas along East side of Manook St. Private parking is prohibited at all times in the aforementioned unloading areas.

*Unloading Area 1:* In-front of Esperida Trading  
*Unloading Area 2:* In-front of Ronnie Co Enterprises

2. All buses with bus station after Herrera St. arriving at the town center from 7:00 am – 9:00 am shall take Quezon St. before unloading passengers at the PAMANA terminal. Said buses can go back to their bus station after 9:00 am.
3. All PUVs are prohibited to load and unload at the following:
  - a. Manook intersection Herrera Sts.
  - b. Manook intersection Luna Sts.
  - c. Manook intersection Calderon Sts.

## **Section 3. Parking Areas**

1. The following are designated as parking areas for tricycles-for-hire:
  - a. North and south sides of Luna St. from Manook to corner Zulueta St.
  - b. West side Zulueta corner south of Luna St.
  - c. West side Zulueta corner south of Roxas St.
  - d. East side Zulueta St. corner north of Roxas St.
  - e. North side of Roxas St. from Manook to Zulueta St.
  - f. South side of Roxas St. from Zulueta to Quezon St.
2. Only the East side of Manook St. is designated as parking area for private vehicles.

## **Section 4. No Entry/ One Way Traffic**


1. The following areas are designated as no entry or one way traffic to all vehicles:
  - a. The portion of Luna St. from Manook to Zulueta St.
  - b. The portion of Roxas St. from Zulueta to Manook St.
  - c. The portion of Diaz St. from Manook to Zulueta St.
  - d. The portion of Zulueta St. from Roxas St. to Diaz St.

## **Section 5. Truck Delivery**

1. Truck deliveries may load and unload cargoes along Manook St. during the following window period:
  - Monday – Friday: 9:00 am – 11:00 am  
2:00 pm – 3:00 pm
  - Saturday – Sunday: anytime
2. The following areas are designated as parking, loading, and unloading of cargoes beyond the window period:
  - a. Quezon St. from corner Diaz up to Mabini St.
  - b. North side of Diaz St. from corner Zulueta up to corner Quezon St.
  - c. North side of Roxas St. from corner Zulueta up to corner Quezon St.
  - d. North side of Luna St. from corner Zulueta up to corner Quezon St.
3. From 6:00 pm until 6:00 am of the following day, truck deliveries may load and unload at any area of market site.

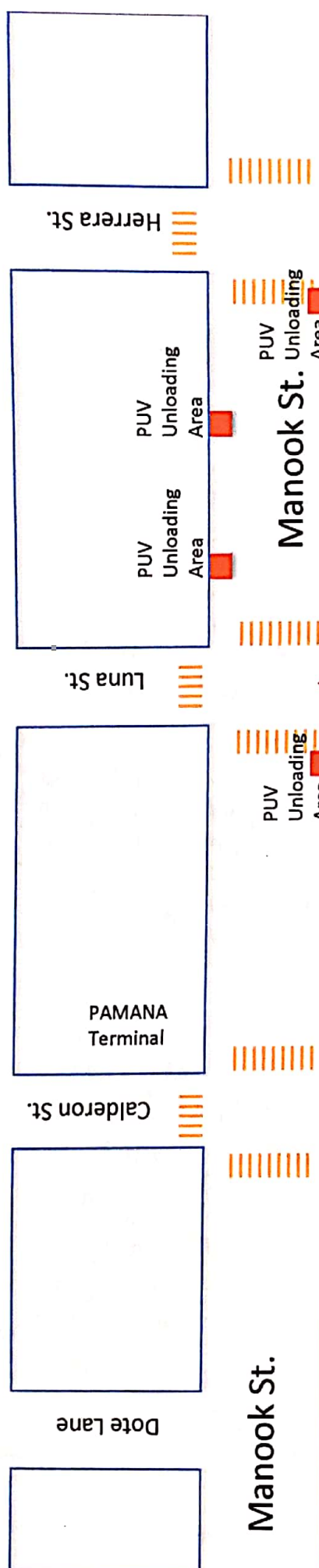
This Executive Order shall take effect immediately until the completion of the covered line canal and the new market building.

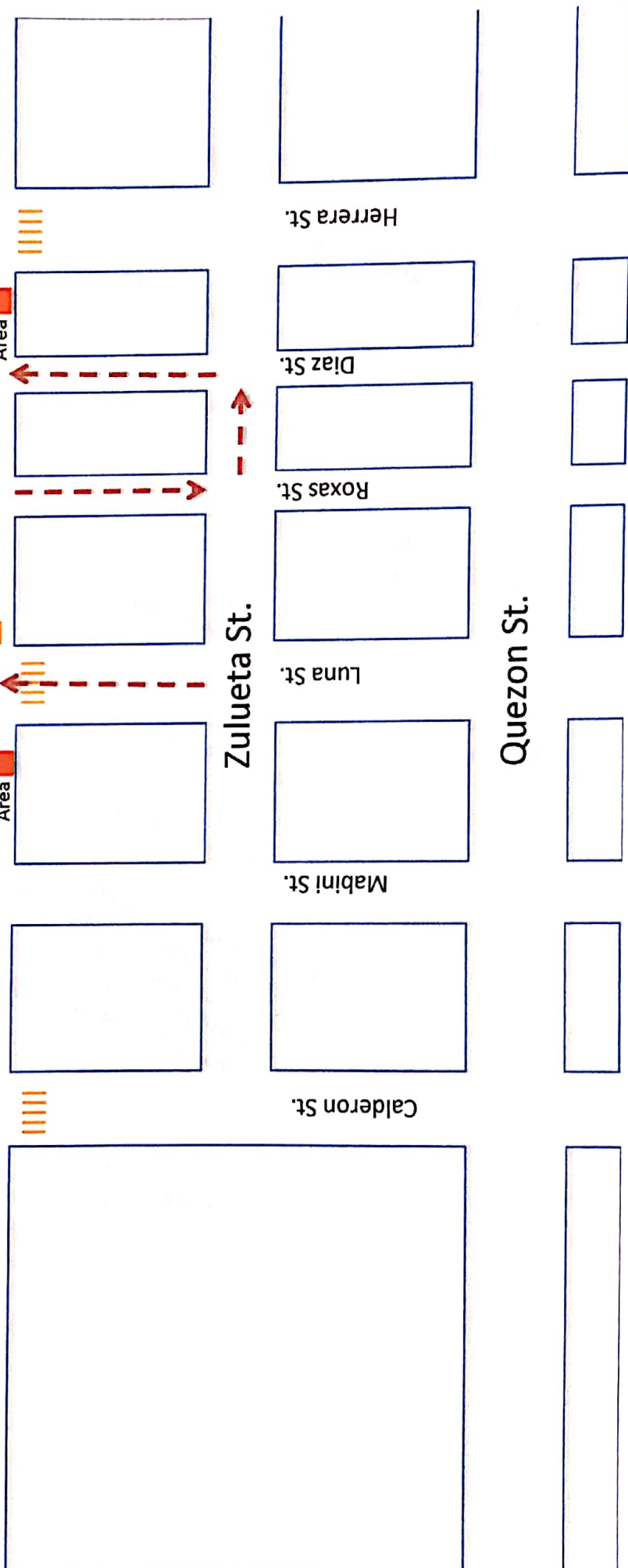
Bonifacio St.
