## **EXECUTIVE ORDER NO. 2017-024**

# ORGANIZING AND CREATION OF THE MUNICIPAL ALLIANCE OF YOUTH ADVOCATES FOR DEVELOPMENT – GUBAT (MAYAD GUBAT)

**WHEREAS**, Section 2 of Republic Act 8044, otherwise known as Youth in Nation-Building Act, provides that the State recognizes its responsibility to enable the youth to fulfill their vital role in nation-building;

**WHEREAS**, Republic Act 10748, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015 and its Implementing Rules and Regulations, provides for the creation of a Youth Development Office in every province, city and municipality;

**NOW THEREFORE I, SHARON ROSE G. ESCOTO,** Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

**Section 1.** Organizing the Municipal Alliance of Youth Advocates for Development - Gubat or MAYAD Gubat in recognition that the youth participation and active engagement is vital to the development of the municipality and can make a difference in addressing different issues and concerns of the community.

MAYAD – Gubat is a federation of all the Barangay Task Force on youth from all of the 42 Barangays and other youth organizations coming from different sectors, and individual youth leaders under one umbrella organization.

A committee will be created to oversee and supervise the programs and activities of the organization. The committee shall be chaired by the Local Youth Development Officer and shall be composed of the representatives from different agenda for development (Social Protection, Health, Environmental Protection, Quality Education, and Cultural and Moral Regeneration)

### Section 2. Functions.

- (a) Facilitate the preparation and submission of programs and activities for youth in accordance with the programs jointly designed and implemented by the National Youth Commission (NYC) and DILG;
- (b) Monitor the progress and oversee the implementation of the MAYAD initiated projects;
- (c) Provide technical, logistical, and other support in the conduct of the mandatory and continuing training programs and to such other programs of NYC and DILG

- (d) Provide technical, logistical and other support to programs and services of individual organizations;
- (e) Facilitate the preparation of quarterly progress reports of physical accomplishment, fund utilization, and report of disbursements;
- (f) Performs such other functions as may be prescribed by law, ordinance, or as the LCE , the DILG, or the NYC may require.

**Section 3. Funding.** Funds needed to carry out the provisions of this Executive order shall be provided from funds under Mayor's Office – Sports Development and Youth Activities.

Section 4. Effectivity. This order shall take effect immediately.
